

section 5 (1) (a)
4. Section 5 (1) (b) of the Principal Act is amended, by substituting for the expression, "N500" in line 2, the expression, "N1,000,000". Amendment of  
section 5 (1) (b)
5. This Act may be cited as the Endangered Species (Control of International Trade and Traffic) (Amendment) Act, 2016. Citation




