Commencement

ENACTED by the National Assembly of the Federal Republic of Nigeria:

1. The Niger Delta Development Commission (Establishment, Etc.) Act No. 6, 2000 (in this Act referred to as "the Principal Act") is amended as set out in this Act.

Amendment of Act No. 6, 2000

2. Section 14 (2) of the Principal Act is amended, by substituting for paragraph (b), a new paragraph "(b)":

Amendment of section 14

"(b) 3 percent of:

- (i) the total annual budget of any oil producing company operating onshore and offshore, in the Niger Delta area; and
- (ii) the total annual budget of any gas processing company in the Niger Delta area, excluding the cost of feed gas."
- 3. This Act may be cited as the Niger Delta Development Commission (Establishment, Etc.) (Amendment) Act, 2017.
