MINISTERIAL ORDER N° 7/DC/04 OF 07/06/2004 SPECIFYING THE CONTENT OF THE REGULATORY BOARD'S REGISTER OF TELECOMMUNICATIONS ACTIVITIES

The Minister of Infrastructure,

Given the Constitution of the Republic of Rwanda of 4 June 2003, as amended to date, especially in its Articles 120 paragraph one and 121 paragraph one-2°;

Given Law n° 44/2001 of 30 November 2001 governing Telecommunications, especially in its Article 12 , paragraph 1;

Given Law n° 39/2001 of 13 September 2001 establishing an Agency for the Regulation of certain public utilities, especially in its Article one;

After consideration and approval by the Cabinet, especially in its session of 28 January 2004;

ORDERS:

CHAPTER ONE: GENERAL PROVISIONS

Article one: Definitions

In this Order, the terms referred to below shall have the following meanings:

Board The Board of Directors of the Rwanda Utilities Regulatory Agency

established by Law n° 39/2001

Official Gazette The Official Gazette of the Republic of Rwanda

Law n° 39/2001 Law n° 39/2001 of 13 September 2001 establishing an Agency for the

Regulation of certain public utilities

Law n° 44/2001 Law n° 44/2001 of 30 November 2001 governing Telecommunications

Minister responsible for telecommunications

Republic The Republic of Rwanda

In respect of other terms, and except where provided otherwise hereinafter, the definitions set forth in Law n° 39/2001 and in Law n° 44/2001 shall, where applicable, apply to this Order.

Article 2: Scope

This Order specifies the telecommunications-related content of the register (the "Register") kept by the Board pursuant to Article 12 of Law n° 44/2001.

CHAPTER II: CONTENT OF THE REGISTER

Article 3: Items to appear in the register

The Register shall contain, among other things:

- (i) all telecommunications licences granted as well as all radiocommunications licences granted;
- (ii) all modifications made to telecommunications licences and to radiocommunications licences;
- (iii) details of licences which have been suspended or withdrawn;
- (iv) details of licences which have expired;
- (v) all declarations made to the Board;
- (vi) details concerning all persons accredited to undertake installation and maintenance of terminal equipment;

- (vii) all authorisations for installation on public and private land granted by the Board;
- (viii) all notices issued by the Board which either forbid or validate the activities of telecommunications operators;
- (ix) details concerning all penalties imposed by the Board and/or the Courts in accordance with the legislative and regulatory texts governing telecommunications.

Article 4: List modification

On proposal by the Board, the Minister shall add, remove or modify items in the list set forth in Article 3 of this Order.

In such event, the decision for modification shall only be enforceable as of the end of a two (2) month period following its publication in the Official Gazette of the Republic.

CHAPTER III: FINAL PROVISIONS

Article 5: Previous and contrary provisions

All prior provisions contrary to this Order are hereby repealed.

Article 6: Entry into force

This Order shall come into force on the date of its publication in the Official Gazette of the Republic of Rwanda.
